Silverdale Lutheran Congregation Annual Meeting November 19, 2023

Minutes

Call to Order

Congregational President Bradley Posadas called the meeting to order at 12:38 PM. Councilmembers in attendance were Vice-president Scott Slocum, Bob Arper, Scott Grasmick, Jo Schaefer, Karen McNamara, Jacque Story, Teresa Walton, Katie Shaw, Sue Shultz, Pastor William Crabtree, Pastor Jonathan Sansgaard and Jane Rasely who monitored recording and prepared minutes. There was a quorum of congregational members present: 83 in person and 27 via Zoom (see attached list of Zoom attendees).

Opening Prayer and Song

Pastor Bill Crabtree led the congregation in an opening prayer.

Opening Remarks and Instructions

President Bradley Posadas provided instructions in how to participate in the meeting via Zoom.

Review and approval of 2022 Annual Meeting Minutes

Motion: I move to accept the 2022 Annual Meeting Minutes as presented. Teresa Walton/Susan Shulz: Passed Unanimously

Financial Report

Bookkeeper Rick Cotter presented an overview of end of year finances with current balances in the various accounts held by Silverdale Lutheran. Total net assets were \$360,034. A review of Income versus Expenses as of October 31, 2023, left us with a negative balance of \$3,247. Benevolences had been paid at a rate of 11% of offerings combining general offering and targeted giving with an overall total of \$75,138 as of the end of 3rd quarter 2023.

Pastors' Video Reports

Video reports were offered online.

Report on ELCA 2022 Churchwide Assembly Constitutional Actions

Pastor Bill Crabtree provided an overview of the action taken by the Churchwide Assembly in 2023 regarding the Evangelical Lutheran Church in America's (ELCA) Constitution and Model Constitution for Congregations with a significant action that could affect the nature of SLC's relationship with the ELCA. He started with reviewing the background of the ELCA and how it came to be detailing SLC's journey from the American Lutheran Church (ALC) organization to Evangelical Lutheran Church of America. As a member of the ALC, member congregations were associated with the ALC but remained independent congregations meaning they would retain their property regardless of whether they remained with their national affiliation. However, in the ELCA, congregations have a much tighter connection to the wider church. ELCA structure is "Interdependent" with each section, Churchwide, Synods, and Congregations, being an expression of one church. Pastor Bill then described the roots of the former ALC as a more congregational structure with congregations having more autonomy than what they do in the ELCA. Also important, was that ALC congregations could decide to withdraw from their synod and maintain control of their church property. When the ALC joined with the ELCA, it was with the condition that if a formerly ALC congregation decided to withdraw from the ELCA, they would not have to ask permission of the ELCA Synod to keep their property. Silverdale Lutheran falls into this category. However, Pastor Bill pointed out that even with this provision, every congregation in the ELCA is bound by the mandatory sections of the Model Constitution.

In 2022, the Church Wide Assembly proposed a review of the ELCA Constitution which includes the Model Constitution for Congregations with a presentation of its findings to occur at the 2025 Church Wide Assembly. Pastor Bill spoke about the criteria in the motion that would be used for the review. The full motion from the ELCA is:

"...To direct the Church Council to establish a Commission for a Renewed Lutheran Church comprised of leaders of diverse representation from all three expressions that, working in consultation with the Conference of Bishops and the Church Council, shall reconsider the statements of purpose for each of the expressions of this church, the principles of its organizational structure, and all matters pertaining thereunto, being particularly attentive to our shared commitment to dismantle racism, and will present its findings and recommendations to the 2025 Churchwide Assembly in preparation for a possible reconstituting convention to be called under the rules for a special meeting of the Churchwide Assembly." [CA22.01.06]

It was unknown at the time what specific changes might be proposed after this review, but Pastor Bill wanted everyone to be aware that as an ELCA congregation, we would be bound by the "Model Constitution for Congregations" even if we as an individual congregation did not ratify or update our constitution as a result of those changes. In other words, it is possible the ELCA *could remove* the current provision that former ALC congregations, if they do sever their relationship with the ELCA, do not need to get permission from the Synod to retain their property. Pastor Bill felt it was important to make sure SLC members understood the nature of our relationship to the ELCA versus the way it was in the former ALC.

Benevolences/Budget Presentation and Adoption for 2024

Bookkeeper Rick Cotter presented the proposed benevolences for 2024 noting that Kids Town international was removed from the list and the 5% allotted to it was added to Council Outreach where it could be used for various outreach activities.

Motion: I move to accept the 2024 Benevolences as presented. Katie Shaw/Craig Miller: Passed Unanimously (discussion below)

- Don Jukam asked for the congregation to reconsider adding Kids Town International to the benevolences.
- Billie Jean Liedal asked if the ELCA supported Kids Town International. No one had the answer.

Motion: The motion would be to retain Kids Town from under the 5% listing of our 2024 benevolences as part of the 1.5%, to retain it, in order to provide the balance in our benevolences.

Don Jukum/John Adair: Motion did not pass (discussion below)

- Billie Jean Liedal stated she opposed the motion as she felt SLC should focus on local work as we had more influence to make a difference locally.
- Betty Koster asked if Don Jukam knew whether SLC pulled their support, how much it would affect the organization. Rick Cotter stated that as of 3rd quarter, SLC had contributed \$1,600 to date.
- Ellen Posadas asked about Hearty Meals funding and where they would go if the 2024 Council Outreach budget was reduced to 5% again.
- Deb Marsch mentioned that Hearty Meals had recently received Thrivent grant dollars donated by congregational members and that Hearty Meals would be cutting back on some of the supplies they had been using.
- Billie Jean Liedal suggested that some of the higher receiving outreach programs could give some of their percentage to Hearty Meals so that it had the support it received in the past.

Rick Cotter presented the 2024 Budget outlining the five areas which included Administration, Facilities, Programs, Salaries, and Benevolences for a total budgetary increase of 2.4% and total of \$1,056,249.

Motion: I move that we approve the 2024 budget as projected. Gerald Ericksen/Sharon Canley: Passed Unanimously (discussion below)

• Wayne Ferber asked about the Youth and Family Assistant raise to \$52,000. President Bradley Posadas explained there was a compilation of three positions into this newly created position. The total salary was then brought up to a par with the Synod level for this type of position.

- Kay Kersten asked for clarification on which position was being spoken about. She mentioned that young families and youth were paramount ministries in SLC, and we needed dedicated people to lead this work.
- Marla Scott spoke about how hard Jessica worked and that she was drawing preschool families into our church and that her work was important.
- Denyse Hemmersbach asked if this would bring her completely up to Synod standard so next year would just be a COLA increase. It was confirmed this would bring the position up to full Synod standard.

Nominating Committee Presentation for 2024

The ballot was presented by Pastor Bill Crabtree. Ray Schaefer was added to the ballot as an alternate for the Martha and Mary Board.

- Billie Jean Liedal asked for clarification on the number of committee members to be elected.
- Bob Arper offered to be an alternate for the Lutherhaven Board.

Elections and Voting

President Bradley Posadas asked for a vote to approve the ballot as a slate. Passed Unanimously

Voting for the slate of nominees was held. Passed Unanimously

Closing Remarks by Council President and Pastor Bill Bradley Posadas provided an overview of 2023 accomplishments.

Other Business

Closing Prayer and Adjournment

Pastor Jonathan Sansgaard led a closing prayer.
